The 2013 1st Summons for the Small Grants Program (SGP) of the Global Environment Fund was successfully completed Certificates were handed over to projects from many provinces, and the State Secretary of Environment and Sustainable Development acknowledged the importance of SGP, admitting the value and positive impact of the program, as well as the success of this first edition of the operational phase of the GEF 5 Argentina.

The Small Grants Program of Argentina successfully completed the selection process of the 2013 first Summons - which supports Nongovernmental and Community Organizations and helps them to carry out projects that contribute to environmental conservation and community development in the Northeast region of Argentina (NEA). Twenty seven initiatives were approved this time, which according to the National Managing Committee of SGP Argentina, will help to improve the conditions of communities and natural environments in the provinces of Chaco, Corrientes, Formosa, Misiones, Entre Rios and North Santa Fe.

Certificates were handed over to the approved projects in the Northeast provinces. They were under the hand of Mr. Martin Santiago, UNDP Resident Representative and Resident Coordinator of the UN in Argentina, and were delivered in the presence of national and provincials authorities, UNDP staff and the Argentinean coordination of SGP. Mr. Juan José Mussi, State Secretary of Environment and Sustainable Development, talked about "the importance of the SGP, whose support initiatives contribute to the care of Mother Earth". He also stood out the work of SGP in articulation with the Argentine government and the ones of the provinces where the program is implemented.

The SGP-Argentina is an initiative of the Global Environment Fund (GEF) on the agreement of the Argentine Government. It is executed by the United Nations Development Program (UNDP). In the operation phase number 5 (OP5) of the GEF the priorities are climate change mitigation, biodiversity conservation, protection of international waters, reduction of the impact of persistent organic pollutants, sustainable management of native forests and the prevention of land degradation. This phase also aims to create sustainable development in the communities.

To ensure transparency of the summons, the National Managing Committee of SGP-Argentina intervenes throughout the selection process. The United Nations Development Program (UNDP), the State Secretary of Environment and Sustainable Development (SAyDS), the State Ministry of Foreign Affairs (MREyC), the Nature for the Future Foundation (FUNAFU), the Foundation for Development in Peace and Justice (FUNDAPAZ), the Argentine Business Council for Sustainable Development (CEADS), the Forest Bank Foundation, the Foundation Growth with Equity, the National Institute of Agricultural Technology and Tapir Specialist Group of the International Union for Conservation of Nature are part of this Committee.

Next call for OP-5 SGP projets is December 2013.

Established in 1992, the year of the Rio Earth Summit, the GEF Small Grants Programme embodies the very essence of sustainable development by "thinking globally acting locally". By providing financial and technical support to projects that conserve and restore the environment while enhancing people's well-being and livelihoods, SGP demonstrates that community action can maintain the fine balance between human needs and environmental imperatives.

SGP recognizes that environmental degradation such as the destruction of ecosystems and the species that depend upon them, increasing levels of carbon dioxide and other greenhouse gases in our atmosphere, pollution of international waters, land degradation and the spread of persistent organic pollutants are life-threatening challenges that endanger us all. However, poor and vulnerable communities –SGP's primary stakeholders- are most at risk because they depend on access to natural resources for their livelihoods and often live in fragile ecosystems.

The programme provides grants of up to \$50,000 directly to local communities including indigenous people, community-based organizations and other non-governmental groups for projects in Biodiversity, Climate Change Mitigation and Adaptation, Land Degradation and Sustainable Forest Management, International Waters and Chemicals.
